With reference to the marginally named man's case, the Paymaster-General claims that their records show Bamford to have been struck off strength as a deserter and no Part II Orders have been promulgated taking him on strength as a recovered deserter. L.P.C. cannot be issued until the necessary Part II Orders has been published taking him on strength, and stating the punishment awarded for his absence without leave. From the man's own statement he was apparently absent without leave from the date of expiration of leave which he obtained in Germany from his Battalion on the 23/12/'18, until he reported himself to the 12th Reserve Battalion, January 18th, 1919. He was evacuated to the Special Hospital, Witley, from the 12th Reserve. He was apparently sent from the Special Hospital, Witley, to the 1st. C.O.R.D. He was taken on strength of this Wing from the 1st. C.O.R.D., with effect 24/5/'19. As the 12th Reserve is now defunct, will Headquarters please take this matter up with the proper authorities.

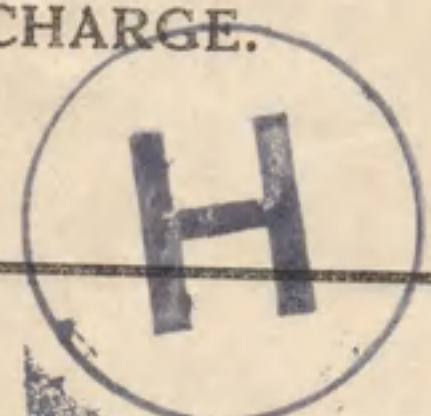
