C.G. Williams, formerly of Lindsay, Ontario, was one of the Trustees, and in order that the Account may be adjusted, an order must be received, signed by, not only Colonel Fee, but also Lieut. Col. Williams, before the Account can be paid.

Several communications have been passed from these Headquarters to Toronto and other places in an endeavor to locate Colonel Williams, but up to the present, no reply has been received from him. These Headquarters have been informed that the Officer, in question, is now lecturing in the United States. However, a communication has been dispatched through the Navy League at Toronto, and it is hoped that a reply will be received in the course of a few days. 

Replying to Headquarters' letter of the 28th ult., on the marginally noted subject, I beg to state that this matter has been the subject of considerable controversy between the Trustees of the Battalion Regimental Fund at Lindsay, this Office and Lieut.Col. Fee, formerly Commanding Officer, 109th O/S Battalion, C.E.F., who is now overseas.

An order was passed by Lieut.Col. Fee through this Office upon the Trustees of the Fund, to cover the Cash Debit Vouchers against the Unit, but it appears that Claims, already passed to the Trustees, amount to several hundred dollars more than the total amount available for distribution, hence this Account could not be adjusted until the Trustees had conferred with Lieut.Col. Fee.

The matter has been left in abeyance awaiting reply from Lieut.Col. Fee now in France.
